



## 2017 Traffic Fatality Monthly Report

As of August 11, 2017, the included table summarizes July traffic fatalities and all 2017 year to date traffic fatalities (through July 2017), which adhere to the San Francisco Vision Zero traffic fatality case definition<sup>1</sup>. For comparison purposes, 2014- 2016 traffic fatalities through July are provided, as well as year-end totals. 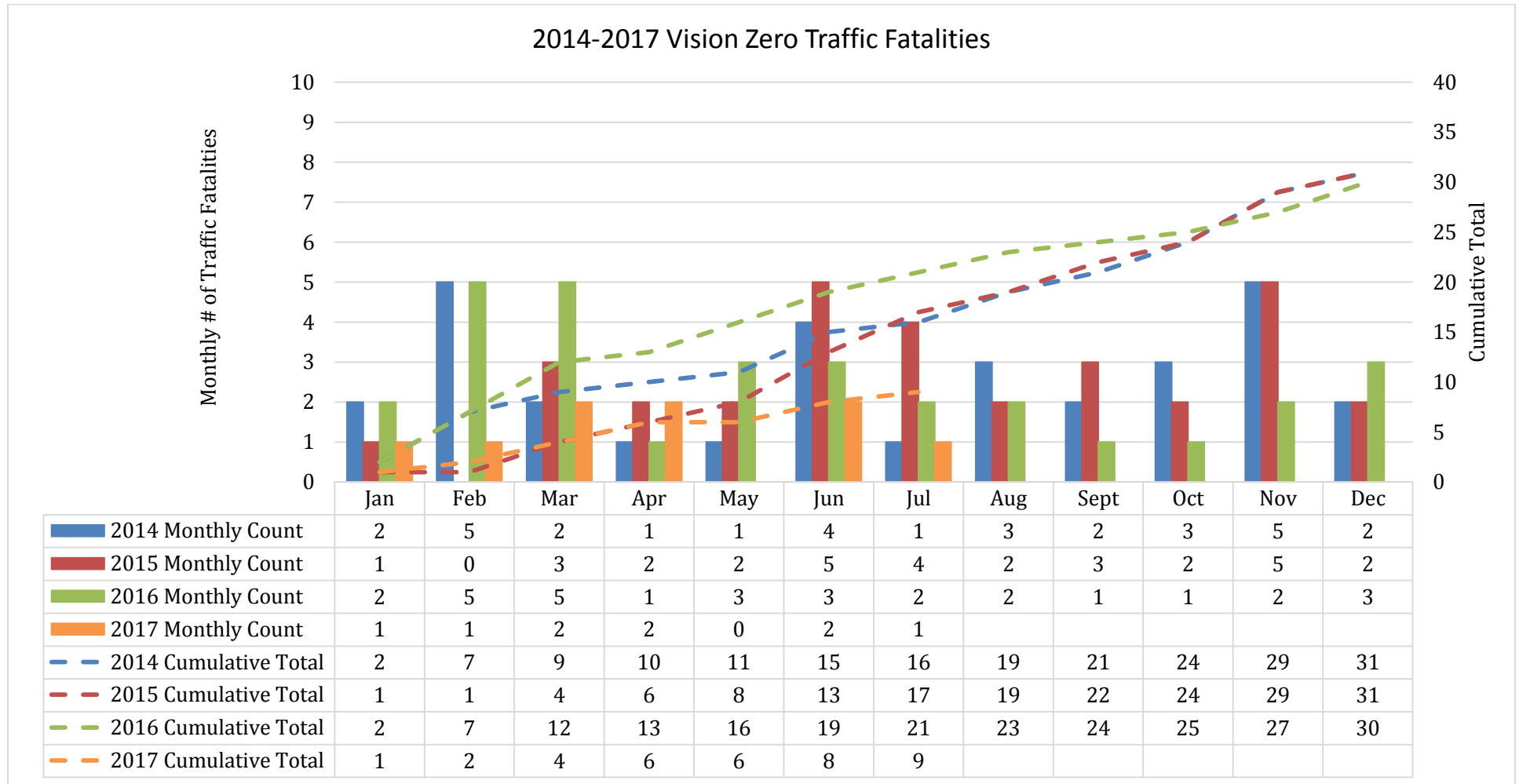
